### **DISCUSSION/ ACTION ITEMS**

The Recreation Director updated the Recreation Board on the discount movie theater tickets. R/C Theaters has moved into Franks Theater in Queensgate Shopping Center. The Township will no longer be selling Franks Theater tickets but will be offering R/C Theater discount tickets soon. In the meantime, R/C Theaters will be accepting Franks Movie Theater tickets until January 31, 2020. Although it is advertised in multiple places, it was suggested to continuously post reminders about it on social media.

Discussion was had about York Township Softball.

Discussion was had about pickleball. The Recreation Director proposed to add a registration fee for the pickleball program. One of the main purposes for the fee is to first make an attempt to solve the problem of the tree that sheds a cottonlike substance on the pickleball court at Fitz Park. It was proposed to approve for the tree to have the spray treatment completed in 2020 before considering adding additional courts on the existing tennis courts. This step was suggested first based on the multiple complaints from players last year concerning the "slickness" the cottonlike substance created and the safety of the players. It was also suggested that if the treatment is successful, to make another attempt at cleaning the courts. Once treatment and cleaning are completed to the satisfaction of the Township, it was suggested to look into the possibility of having one court lined on the Fitz Park basketball court if appropriate budgeted funds remain. Joe E. made a motion to approve the proposal and suggestion. Joe H. seconded. All approved.
