Public Works Report: Robert Miller

Chapter 94 Report – Mr. Miller reported that he has completed his part of the Chapter 94 report and passed the info onto Gannett Fleming. Some of the highlights of the reports were that our crew flushed and televised a total of 141,000' of pipe and helped with 7 repairs. York Township also lined a total of 7,505' of pipe using a cured in place liner. We installed a muffin monster at MPS and installed a valve vault at the IDPS. We added a second trailer mounted Godwin Dri- prime Model CD150M pump to our equipment list. This was purchased in December at a discounted price.

York Township Manager: Gary Milbrand

York City Inter-Municipal Agreement – Mr. Milbrand reported that he met with York City in December of 2016 and we are extremely close to a consensus on the inter-municipal agreement with them. All the municipalities that flow into York City must agree with each inter-municipal agreement.

York City has put the lease agreement idea on hold for now. Once the inter- municipal agreement is completed with York city it will necessitate a new agreement with York Township and Spring Garden.

Engineer's Report: Ron Jager – Gannett Fleming

Chapel View PS sewer connection – Mr. Jager reported that no work has been done on this proposal as of this date.

Green Valley PS upgrades- Mr. Jager reported that the surveying work for this project is going on now.

Bridgewater - Gannett Fleming is doing onsite inspections of the sanitary sewer lines that are being constructed as part of this project.
